If cross entering pay only the highest judges fee and one video monitor fee. Faxed entries are required to have credit card info included to hold entry; check must be mailed immediately. Entry fees must be PAID IN FULL to be eligible for the draw. A one-time \$25 COMPUTER FEE will be charged for horses not pre-entered by MARCH 15. However, classes may be added at show with no penalty. If entry is received after class has been drawn, there will be a \$200 PENALTY for each class entered. The show management reserves the right to interpret these rules and regulations. All decisions will be final. By way of making an entry, the exhibitor is assuming responsibility for knowledge of the rules and releases show management from any claims or losses. The show management reserves the right to modify or change conditions for the National Reining Breeders Classic Show. By my signature, I agree to these conditions.
